


ARE YOU CONSIDERING RETIREMENT?

Are you a full-time employee, age 60 or older? If so, there are many options to consider before retirement regarding your NHRS Pension Benefit, and health and dental options through Merrimack County. NHRS PRE-SELECTION OF SURVIVORSHIP OPTION BENEFIT

Are you a full-time employee, over the age of 60? Pre-selection allows an eligible member to elect a maximum Survivorship Option for a beneficiary(ies) in the event of the member's death while eligible to receive a monthly pension benefit and before filing an application for Service Retirement. If a member dies while a pre-selection is in effect and if the beneficiary named on the Pre-Selection Before Service Retirement form is the same as the beneficiary named under the Designation of Death Beneficiary(ies) Pre-retirement form, then the member's designated beneficiary(ies) may choose to receive either the Survivorship Option or the lump sum payment under the Ordinary Death Benefit or Accidental Death Benefit, whichever applies.

This is not an automatic benefit. Eligible members must submit a Pre-Selection Before Service Retirement form to NHRS to activate this benefit. Please contact HR for more information and how to obtain the form.





UNUSED FSA FUNDS

Did you receive notification that you have unused FSA Funds remaining from 2023? You have until March 15, 2024 to expend any unused funds before forfeiting the balance. Log into your Benefit Advantage Portal to view your balance.

The Boscawen Campus has a posted speed limit of 15 mph, SLOW DOWN!


Stop at all stop signs and crosswalks, if someone is waiting.

<u>Payroll Policy Reminder</u>

Merrimack County's payday is Thursday. Management made the decision to no longer allow employees to receive paper payroll checks prior to Thursday of payday effective December 1, 2022. All employees who receive a paper payroll check will be able to pick up their payroll check at their work location on Thursday of payroll week.

Employees who choose to use direct deposit as their means of payment typically see their payroll checks deposited into their account by Wednesday of payroll week. The County has advertised and notified employees of the availability of direct deposit to encourage employees to move to direct deposit.

Currently there are employees who continue to receive payroll checks. The County will continue to issue paper payroll checks to those employees who require it; however, the checks will not be released until the morning of Payday.

College/post grad degrees: Undergrad: Bachelor of Science in Social Work from Skidmore College in Saratoga Springs, N.Y. (2008); Graduate degree: Master of Social Work from the Silberman School of Social Work at Hunter College (formerly known as CUNY Hunter School of Social Work - CUNY stands for City University of New York) (2009). Subsequently passed the licensing exam in New York to be a Licensed Master Social Worker (LMSW) but I put my social work license in inactive status when I went to law school. Doctorate: J.D. New England Law Boston (2018); subsequently admitted to the New Hampshire Bar upon passage of the bar exam in 2018.

What motivates you to give back to your community?

Generally, in both my legal and social work careers - the opportunity to help empower those who feel as they do not have a voice, to find theirs. If I am able to provide a victim of crime with an emotionally safe space and a transparent explanation about what the criminal justice process entails so that they feel able to make an informed decision that helps their healing process - I feel as though I have done my job. Our community is full of amazing people and their stories of strength and resilience are so motivating - you just have to listen.

What advice would you give your 22-year-old self?

Just keep going and trust your instincts. When you get knocked down, even if you have to lay on the ground for a little while -get back up - and keep going. Just because someone is older than you or has been doing something longer than you have does not automatically mean they are right or that they know more or know better. 'Street smarts' are a lot more valuable than 'book smarts.' Your gut should be your guide - listen to it always, but not blindly.

What would make New Hampshire more attractive to young professionals?

Lack of affordable housing and available childcare are two of the biggest factors that drive young professionals away from our state. This, in turn, greatly affects the opportunity to diversify (which is sorely needed) and to build successful and positive communities. Additionally, more public transportation and a direct manner of traveling from Manchester to New York City (i.e., a train) wouldn't hurt.

Do you see yourself living and working in New Hampshire at age 55-plus?

Yes. I am so grateful for the past six years of working as an Assistant County Attorney - as a public servant in New Hampshire. It has allowed me to see and understand so much about our state, its systems, and into the hearts of those who live here. My role has helped me identify, in my opinion, where we are doing well and where we can improve. I have met incredible people along the way who have supported, taught, and helped me. This motivates me to stay and work to help keep New Hampshire improving, welcoming, and the place we want to be.

Volunteer activities: Former member of the Board of Waypoint and member of their Children's Lobby from 2019-23. I am not currently involved in volunteer work due to my workload but I have worked in public service since graduating college in the social work and legal fields.

Last major achievement: Selected as one of WZID's 20 Outstanding Women in New Hampshire in 2022. Accepted into the 2024 Class of Leadership New Hampshire - which is a fantastic program for professionals in the Granite State looking to get involved and foster their communities.


